STATE OF UTAH AS FOLLOWS:**

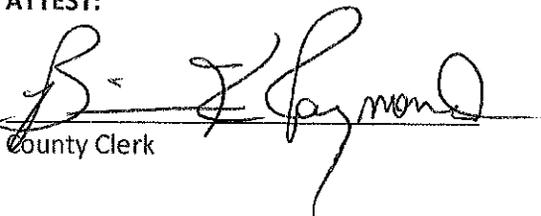
**Section 1.** That the details of this budget are more specifically outlined in the document attached and established as the approved 2024 Budget.

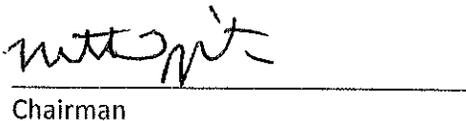
**Section 3.** Effective Date. This Resolution shall become effective immediately upon its signature.
