



**Certified Election Results & Canvass Summary
June Republican Primary Election-June 25, 2024
Report Date: July 9, 2024 at 1:13 pm**

Daggett County continues to be a Vote By Mail County. There were 461 Ballots sent out to registered Republican Voters. We had 57 ballots returned by mail (21.19%); 172 ballots returned through drop boxes (63.94%); and 40 people voted in person (14.87%), including 2 provisional ballots. Of the returned ballots we had 21 ballots rejected for non-matching signatures, with 20 of those ballots being cured and counted. There were 266 ballots counted for a 56.36% turnout. We had six ballots returned undeliverable and two ballots received by mail were postmarked too late, while 1 non-matching signature turned out to have been signed by a wife with permission as her husband was out of town and not returning until after the election.

Early Voting in Manila took place on June 14, June 19, and June 21st in Manila. Early voting in Dutch John was held on June 20th. A total of 13 people voted in person during these 4 days. Election Day was Tuesday, June 25, 2024 and there were 27 people that voted in person, including one non-republican that slipped through the cracks and two provisional voters..

The Election was audited on Tuesday, July 2, 2024. No Public attended, but Commissioner Jack Lytle and two representatives from the Lt. Governor's Office attended and observed the proceedings. All paper ballots matched the electronic ballot and the Cast Vote Record. Release dates for ballots counted being uploaded to the Lt. Governor's Office were: June 25, 2024, and July 1st and July 3rd, 2024.
