

BOARD OF CANVASSERS FOR THE JUNE 26, 2018 PRIMARY ELECTION,  
HELD ON JULY 10, 2018 BEGINNING AT 1:00 PM  
IN THE COMMISSION CHAMBERS IN DAGGETT COUNTY, UTAH

The Board of Canvas convened.

Daggett County no longer has polling locations throughout the county. We are now an ALL-BY-MAIL/ABSENTEE County. EARLY VOTING took place June 18, 2018 to June 22, 2018 at the Clerk's Office as well as the Dutch John Conference Hall (Eleven votes were cast in Manila and 17 votes in Dutch John). Ballots were mailed in as well as dropped off at the Clerk/Treasurer's Office. The County Courthouse was considered a Vote Center as per Utah Code on Election Day (16 ballots were cast by machine).


There were 455 By Mail/Absentee ballots issued to voters for Daggett County; 27 Republican ballots were returned; and 3 Democratic Ballots were returned undeliverable; no blank ballots were processed; 2 ballots came in postmarked by the deadline; no ballots came in postmarked *after* the deadline; there were 4 provisional ballots that can all be counted, plus there were 12 ballots that originally did not have matching signatures and all but one were able to be counted. That person was contacted, but did not return their affidavit.


Release dates for ballot uploads to the Lt. Governor's Office for results: June 26, 2018, and July 10, 2018.




